

Our Whakataukī

Ko te hōkai nuku Ko te hōkai rangi Ko te hōkai a tō tupuna a T̄anenuiarangi

The whakataukī tells how Tāne asended to Te Toi-o-ngā-rangi, the highest heaven, to obtain ngā kete o wānanga – the three kete (baskets) of mātauranga (knowledge) – and bring down to earth for all to share. Human life and knowledge were said to originate in the realm of Ranginui (the sky father). Knowledge of these kete is important to sustain tuarite, or balance.

Applied in the context of research it is a reminder to us of the tikanga, or processes, that are required to maintain this balance and ensure that the mana of all participants and subjects are upheld. In the wider context of dayto-day life this knowledge is fundamental to maintaining balance within our communities, with our loved ones, and within ourselves.

Looking back, the kaimahi at Community Research have had an amazing year sharing and promoting your insights. We hosted conversations on equity, belonging, AI, and Te Tiriti o Waitangi, bringing together lived experience, practitioners, researchers, and influencers. We continued to publish on Te Tiriti-based practice, community resilience, the role of Tangata Whenua and of diverse Tangata Tiriti community knowledge in shaping better futures.

We are also excited to be unpacking and promoting the Community Research Code of Practice as a first, big, step to defining what is best practice for researchers and organisations to follow when conducting research for and with communities.

Coming up soon is our semi-regular Te Auaha Pito Mata Awards celebrating the impact of emerging community researchers in Aotearoa. Really looking forward to this!

Finally, we remember the many amazing people we have lost this year including Tā Tumu Te Heuheu, Takutai Moana Kemp, Dame Iritana Tāwhiwhirangi, Fa'anana Efeso Collins, Tofilau Yolande Ah Chong, Nan Liu, and Paula Bloomfield.

No matter what the future brings, in the words of Nigel Latta, "in the end, there is only love."

Kaimahi / Operations

Tēnā koe

It has been another year of uncertainty and challenge, but also one where the resilience and strength of our communities shone through. Globally, our landscape continues to be filled with war, disaster, displacement, environmental crises, and emerging health threats, all of which maintain a backdrop of instability. Here in Aotearoa, the ongoing cost-of-living and housing crises have continued to impact whānau and communities.

Added to these pressures are renewed challenges to Te Tiriti o Waitangi, with policies and rhetoric fuelling suspicion and resentment. The current government's moves to roll back commitments to Te Tiriti threaten not only the rights of tangata whenua but also fracture the foundation for equity and justice in Aotearoa. These actions risk embedding inequity further into our systems, undermining decades of mahi by tangata whenua, communities, and allies who have worked tirelessly for recognition, fairness, and partnership.

For Community Research, this has reinforced more than ever the importance of Te Tiriti-led research and practice. Like many others across the motu, we made submissions opposing the Treaty Principles Bill and the Regulatory Standards Bill, and our team joined the hikoi in solidarity. We also hosted a webinar exploring the role of Te Tiriti o Waitangi for ethnic communities who call Aotearoa home.







This year we continued to invest in strengthening our organisation both internally and externally. Internally, we focused on ensuring our small team is positioned to operate sustainably as a Te Tiriti-led organisation. Externally, we strengthened connections with values-aligned changemakers and researchers across the sector. While less visible, these investments and relationships are critical – they enable us to use our resources strategically and to collaborate for greater collective impact.

In December 2024 we relocated our office, co-locating with Hui E! Community Aotearoa and Tūao Aotearoa Volunteering NZ. Sharing a workspace has enhanced collaboration and reduced operating costs, allowing us to focus more resources on our sector mahi.

In line with our new strategy, we refreshed our Theory of Change, clearly articulating the impact we seek to achieve through our activities and actions. This framework sharpens our focus and now guides how we measure progress and hold ourselves accountable to the sector we serve. We completed our first annual CR Survey to gather feedback on how we are doing and where we could strengthen our mahi.

For small community organisations, being able to show the difference that you are making is crucial – particularly in such a challenging funding environment. Our WhatWorks website provides a range of evaluation tools and frameworks to help community organisations tell the story of their impact. This year we've been actively refreshing this valuable website.

We also continued to create spaces for korero and collective learning. The release of the Community Sector Insights Report, commissioned by Community Research, distilled key learnings from nine substantive research reports published between 2020–2024. Covering iwi and hapū, voluntary organisations, faith-based groups, NGOs, advocacy groups, charities, sports groups, and community-led initiatives, the report highlighted sector strengths, ongoing challenges, and opportunities for future action.











Much of what we identified is already known – the challenges and strengths have remained consistent over many years – but pressures on funding, capacity, and demand have intensified. Our hope is that this research supports the sector to move from what is known towards positive, actionable change.

Ngā mihi nui to our kaimahi team – Bev, Eve, Moana & Ray – your commitment, creativity, and aroha have powered everything we have achieved this year. We sadly farewelled Raylyn Christian, our Communications Lead, in early 2025 and acknowledge with gratitude her significant contribution to Community Research over the last few years.

We also participated in the Victoria University Internship Programme and were fortunate to be matched with Madi Brokenshire. This experience has been a wonderful reminder of the value of having rangatahi involved in our work, and the fresh perspectives they bring. Thank you, Madi, for your creative vision and contributions to Community Research.

Much of the work that keeps our organisation running goes unseen. Reflecting on the past 12 months, it is humbling to recognise the breadth and impact of our collective efforts. Ngā mihi nui to our kaimahi team – your commitment, creativity, and aroha have powered everything we've achieved. Tēnā rawa atu koutou to all our Kaitiaki for your wisdom and guidance throughout the year.

The following pages share highlights from a year in which we amplified diverse voices, strengthened community capability, and upheld the place of Te Tiriti at the heart of community research in Aotearoa.





Communities in Aotearoa are rich in diverse knowledge. Our role is to amplify community research and share it with others to bring about positive change.



In line with our strategy, over the past year our mahi has focused on making community research more accessible, supporting researchers, strengthening relationships across the sector, amplifying diverse voices, centring Te Tiriti o Waitangi, and ensuring our organisation is structured to thrive.

The success of our activities, and their contribution towards the outcomes we sought to achieve, can be measured through indicators drawn from multiple sources.



Develop and share useful content and resources of value to the sector

We created and shared resources that helped communities and researchers access knowledge more easily and apply it in their mahi.

This year, we saw strong engagement with our digital platforms, showing that our content was valued and widely used. Survey respondents indicated they appreciated the audience friendly format and increased visibility of community research and knowledge-making. Activities increased their awareness and good research practice content was perceived as useful. In response to the rapidly changing digital landscape, we updated the search engine optimisation for our website to maintain visibility, and continued rolling out updates to our What Works website.

We launched our 'Queerness in Aotearoa' project, which is seeking to work with LGBTTQIA+ communities to set up a special collection of community-led research and resources of use to those communities.

We introduced a new 'Join Our Community' form, which streamlined registration for individuals looking to connect with us and kept them informed about participation opportunities.

- 96,448 YouTube views (up 7%) and 902 subscribers
- 4,035 podcast downloads (up 76%)
- 56,483 website users (down 19%)
- 6,525 Ngā Kete email subscribers (up 18%)
- 5,861 Facebook followers (static)
- 1,205 LinkedIn followers (up 15%)

By improving access and visibility, we laid a foundation for stronger connections with researchers and sector partners, and our ability to inform new audiences.

Provide valued support and connection opportunities to researchers

We supported community researchers by connecting them with each other and with the wider sector. Our work raised the profile of community research and provided opportunities for researchers to share knowledge, make connections, and increase the reach of their mahi. Respondents to our survey appreciated the sense of connection and validation of community researchers and knowledge-makers that our activities foster.

Activities included establishing a Researcher Network for those seeking connection without needing a public profile, and established regular Tautoko online sessions for ethnic, migrant, and former refugee researchers across the motu as a safe space to informally connect and share. As part of our 'Queerness in Aotearoa' project, we hosted the first in a series of planned Tautoko sessions.

- 4 Tautoko sessions for ethnic researchers, with 158 registrations
- 1 Tautoko session for LGBTTQIA+ researchers
- 207 researcher profiles in the Community Researcher Directory
- Launch of the new Researcher Network, with 22 researchers joining
- Established the Ethnic, former refugee and migrant researchers' Tautoko Community Network (42 members)

These connections strengthened the reputation of community research and created pathways for collaboration, feeding directly into our wider sector partnerships.

Grow purposeful relationships with organisations and the sector

By working collaboratively with others toward shared kaupapa, we amplified our collective impact and helped build a stronger sector.

Key collaborations included:

- August: joint webinar/workshop with Aotearoa Migration Research Network (AMRN), presented by Bev Tso Hong, Cayathri Divakalala, Tim Fadgen, and Arezoo Zarintaj Malihi
- November: 'Inclusive approaches and resources for community-led knowledge making and Evaluation in Aotearoa' workshop presentation at ANZEA conference by Bev Tso Hong, plus co-facilitated a session for the Tauiwi Ethnic forum
- December: online conversation in partnership with Tāhono Inclusive Aotearoa, featuring Anjum Rahman, Ganesh Ahirao, Danny Karatea-Goddard, and Vira Paky, exploring Te Tiriti, ethnic community histories, current Treaty context, and visions for the future
- May: reflections shared by Tāhono Inclusive Aotearoa from their third Belonging Conversations roadshow
- Release of Community Sector Insights report
- 4 new webinars hosted, with 570 registrations
- 94% of attendees satisfied or very satisfied
- Launch of the new Allies Network, with 20 community members joining
- Member of the Community Constellation (a collective of community sector peak bodies and capability-building organisations committed to collaborating and working together towards a community-powered Aotearoa that gives effect to Te Tiriti.)
- Engagement with Centre for Data Ethics and Innovation CDEI including providing the "Data as Taonga: Honouring Community Voices in the Cultural Mosaic" article written by Bev.

These relationships, with other values aligned organisations, helped us bring a diversity of perspectives into our work, supporting our goal of amplifying voices that are often underrepresented.

Amplify the voices and perspectives of diverse communities

We highlighted and shared the knowledge of diverse communities, ensuring their perspectives were visible and accessible across the sector. Our survey respondents viewed our activities as inclusive and relevant to diverse communities in Aotearoa. Activities included:

- March: as part of a joint partnership between NZ Chinese Association, Creative NZ,
 Foundation North and Community Research, Bev and Eve travelled to Tamaki Makaurau
 to livestream Tangata Tiriti Tangata o te Kaipuke | People of the Treaty, People of the
 Ventor, amplifying unique perspectives from diverse communities
- · 63 new items of community research added to our website

Through this work, we strengthened the sector's understanding of the issues, experiences, and contributions of diverse communities, and created a stronger platform to embed equity into community research.

Centre Te Tiriti o Waitangi in everything we do

We centred Te Tiriti o Waitangi in all areas of our mahi, strengthening equity and reflecting Te Tiriti relationships in practice.

- 2 submissions made on legislation or policy relating to Te Tiriti (e.g., Treaty Principles Bill, Regulatory Standards Bill)
- 1 hikoi attended
- 2 events specifically focused on Te Tiriti o Waitangi

Upholding Te Tiriti o Waitangi guided our approach across every activity this year, ensuring that our research, partnerships, and community engagement remained grounded in equity and partnership.

Structure and resource the organisation to enable our kaupapa to thrive

We invested in the people, systems, and resources needed to sustain our kaupapa. Strengthening our internal foundations enabled us to continue delivering impact for the sector.

- Relocation to a shared office with Hui E! Aotearoa and Tūao Aotearoa | Volunteering NZ, demonstrating cost savings and stronger collaboration opportunities
- AI Skills workshop and training sessions for kaimahi
- Updates to systems and processes (website refresh and improvements to accessibility of content, new automations, better analytics)

- Accredited member of the Living Wage Movement
- Investing in development opportunities for our kaimahi
- · Ongoing support from our funding partners

These organisation improvements provided improved governance oversight for our Kaitiaki and ensured that our kaimahi team could continue supporting researchers, sharing knowledge, and strengthening sector partnerships in a sustainable way.




WHAKARITENGA PŪTEA Financial Summary

Our reach and engagement this year shows that our resources and activities are being widely accessed and valued across the sector:

- 56,483 website users across Community Research and WhatWorks (down 19% on last year, reflecting sector-wide shifts in online behaviour and search tools).
- 96,448 YouTube views (up 7%), with 934 subscribers.
- 4,035 podcast downloads (up 76%).
- 6,525 Ngā kete email subscribers (up 18%).
- 5,861 Facebook followers (static).
- 1,205 LinkedIn followers (up 15%).

Alongside digital engagement, we worked to uplift researchers and provided spaces for learning and connection:

- 4 new webinars with 570 registrations, and 94% of attendees satisfied or very satisfied.
- 3 Tautoko sessions for ethnic researchers and 1 Tautoko session for LGBTTQIA+ researchers.
- 207 researcher profiles now live in the Community Researcher Directory, alongside the launch of our new Researcher Network.

Our mahi to amplify diverse voices and knowledge continued:

- 63 new items of community research added to our website collections.
- 2 submissions opposing legislation that undermines Te Tiriti o Waitangi, participation in 1 hikoi, and 2 events specifically focused on Te Tiriti.



Organisationally, to strengthened our foundations:

- We relocated to a shared office with Hui E! and Volunteering NZ, creating opportunities for collaboration and reducing
- We continued to update and refine our systems, analytics, and frameworks to support a sustainable, Te Tiriti-led organisation.



Statement of Accounting Policies

Tangata Whenua, Community and Voluntary Sector Research Centre Incorporated For the year ended 30 June 2025

Basis of Preparation

The entity is permitted by law to apply the Tier 3 (NFP) Standard issued by the External Reporting Board (XRB) and has elected to do so. A PBE may apply the standard if it does not have public accountability and has total annual expenses less than or equal to \$5,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Revenue

Revenue is recorded based on the stage of completion of the service at balance date.

General funding or grants with no documented expectations over use

General funding received from government, grants or capital grants are recognised as revenue when the funds are received if there are no documented expectations over use.

General funding or grants with documented expectations over use

If funding is subject to documented expectations over use, the funds are initially recorded as deferred revenue. As the documented expectations over use are met, the deferred revenue is reduced, and revenue is recorded.

Donations and bequests received with no documented expectations over use

Donations, koha, bequests and other fundraising revenue with no documented expectations over use are recognised as revenue when cash is received.

Donations and bequests received with documented expectations over use

Donations, koha, bequests and other fundraising revenue with documented expectations are initially recorded as deferred revenue. As the documented expectations over use are met the deferred revenue balance is reduced and revenue is recorded.

Donated assets

Revenue from donated assets is recognised on receipt of the asset if the asset has a useful life of 12 months or more, and the current value of the asset is readily obtainable and significant. If the assets are difficult to value such as intangible assets, highly specialised assets, or heritage assets these are not recorded.

Interest and dividend revenue

Interest revenue is recognised as it is earned during the year. Dividend revenue is recognised when the dividend is declared.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Tangata Whenua, Community and Voluntary Sector Research Centre Incorporated is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.



Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies

The entity has applied the Tier 3 (NFP) Standard for the first time this year. This new Standard, when applied, supersedes the previous version of this standard Public Benefit Entity Simple Format Reporting - Accrual (Not-for-profit).

Some aggregation changes to items in the statement of financial performance were required on first time application of the Tier 3 (NFP) standard. Comparative amounts have been presented in accordance with the requirements of this standard.

There have been no other changes in accounting policies since the date of the last Performance Report.
