Benefits and outcomes achieved

What Happened?

1. Several hui with the community partners Xtreme Zero Waste, Pare Kore, and Raglan Naturally occurred throughout the term of the grant.
2. Drafts of the revised proposal were developed and feedback from each partner incorporated into each subsequent draft.
3. The new proposal for research and evaluation funding was developed collectively and a final version agreed to by all partners.
4. Discussions on the project management of the initiative are ongoing.

Who participated or benefited?

5. Key people from Xtreme Zero Waste Ltd , Xtreme Zero Waste Trust Board, Pare Kore, Raglan Naturally were involved throughout the process.
6. The Tuakana Teina collective and Te Mauri Tau co-ordinated the re-development of the proposal.

What was achieved?

7. A revised proposal for funding was developed and agreed to by all partners. This was submitted to the Lotteries Community Sector Research Fund
8. There is broad agreement among the partners that a collective approach to evaluation and impact measurement is beneficial for the Raglan community.

What other community benefits or outcomes were achieved?

9. Important community connections have been consolidated and new connections between the different kaupapa of each organisation have been made. The partners have benefited from the development of a shared vision for impact, and there has been shared learning about evaluation and impact measurement.

10. All three organisations are excited by the potential of the project to contribute to ongoing development of our community.
